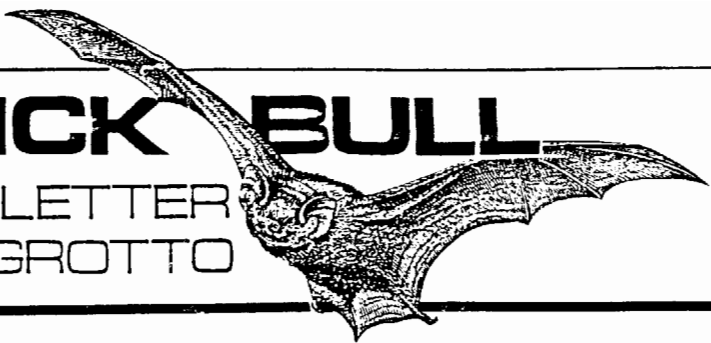

MEMBERSHIP POLICY: Any caver with interests, beliefs, and actions consistent with the purposes of THE MAVERICK GROTTO and the National Speleological Society is eligible for membership. Acceptance of new members is based on payment of dues and a mandatory three trip requirement with at least three different grotto members. These three members shall act as sponsors. At least one sponsor must attend the meeting at which the membership vote is taken. A two-thirds majority vote of the members present will be required for acceptance.

MINUTES OF THE APRIL MEETING

The regular monthly meeting of the Maverick Grotto was held on 11 April 1989 at Smokey's Ribs restaurant.

Chairman Dale Ellison opened the meeting and asked for any trip reports.

Butch Frelia and David Finrock gave accounts of the recent work trip to the new Devil's River State Natural Area near Del Rio. There's a full trip report later in this issue.

Butch also related some of the happenings at the April 1 TSA cleanup at the Longhorn Caverns State Park. A lot of people showed up and a lot of garbage was hauled out. Maybe there will be a trip report in next month's newsletter. (That's a gentle hint from your editors).

Russell Hill told about his unique trip this spring, when he went cave-diving with alligators (actually caimans, a close relative of the gator). Russell was on a trip to Tamaulipas, Mexico. And in addition to some good, new diving, he discovered a new dive shop in Ciudad Victoria where you can get your tanks refilled. Ask Russell about it.

At the last Colorado Bend work trip, the survey of Gorman Creek Crevasse was extended 331 feet. It now has a total length of 1558 feet surveyed, with several hundred feet more known, but as yet unsurveyed. At the back of the main passage, a pair of vertical drops was found, but there was no vertical gear, so the drop will have to wait till the May or June trip. Terry Holzinger brought a line-plot map of the cave, and it really whets the appetite.

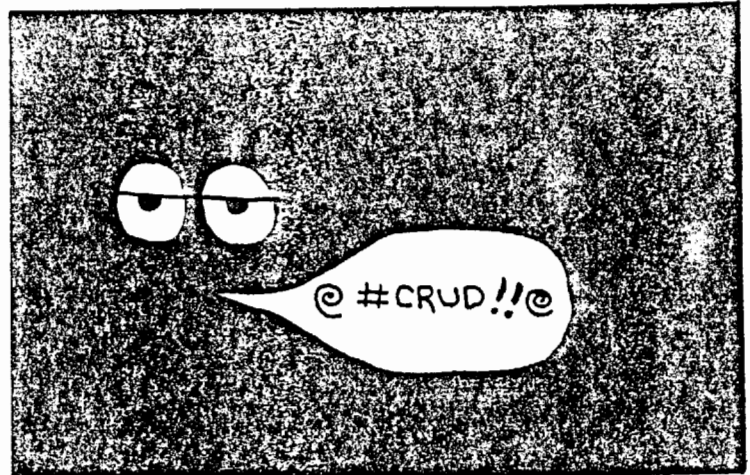
Teresa White gave a treasurer's report indicating a balance of \$616.91. That nice balance is due largely to the fact that Steve and Pat Gentry are continuing to print our newsletter each month, free of charge to the Grotto.

Eruce Anderson made a motion, which was approved by the membership, to clear up an item not addressed in our by-laws: now any former member of the Grotto whose membership has lapsed for non-payment of dues, can be re-instated simply by paying the required dues; the minimum three-trip requirement for new members will not have to be met again.

A Maverick Grotto party is planned for early June. Details are available elsewhere in the newsletter.

The business part of the meeting was adjourned, and an NSS slide program on Scott Hollow Cave in West Virginia was shown, with narration by Butch Frelia.

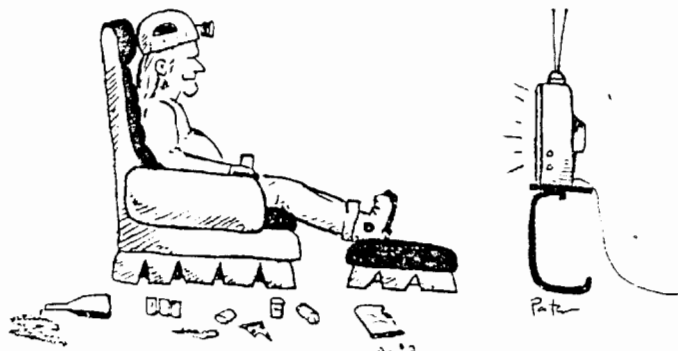

DEVIL'S RIVER TRIP REPORT

 Location: Devil's River State Natural Area
 North of Del Rio, in Val Verde Co., TX

Shari and I made it down the last 25 miles of gravel road west of Loma Alta and arrived at the new park headquarters area a little before sunset. And shortly afterwards Danny Sherrod pulled in as well. The others had arrived Friday evening and had already spent one day ridge-walking and ridge-driving. (Ask Butch Fralia about some of the so-called roads in the park).

Our timing was good, because we were there just in time for the communal dinner. We all prepared something and then browsed through the kitchen at the bunkhouse, sampling a little of everything. The food was one of the outstanding features of this whole trip. Some of the real treats were the freshly caught trout which Page had brought from San Antonio, and the corn-fritters and apple-fritters which Quinta made. (Maybe we'll get a recipe soon).

But even the food had to take a back seat to the HOT SHOWERS available at the bunkhouses. I could get used to that kind of "roughing it".

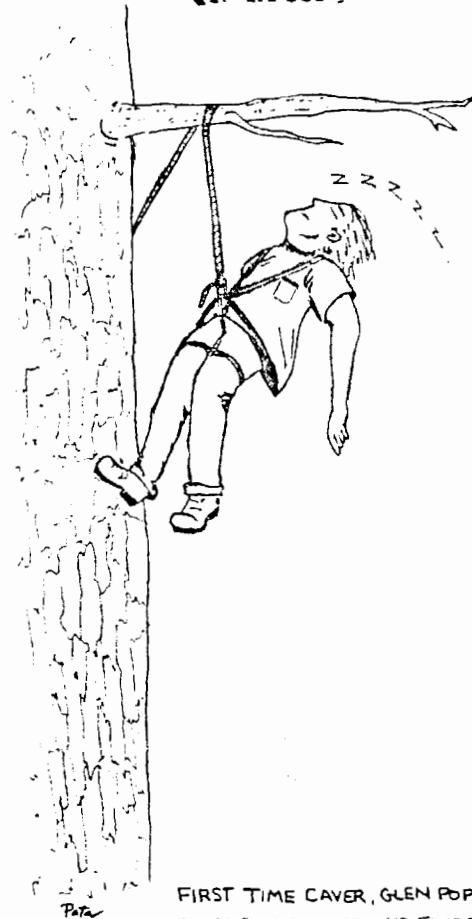
We spent Sunday driving the rough tracks advertised as roads on the topo maps. It would have been impossible without the 4-wheel drive speleo-vehicles. Then we hiked up and down canyons and over ridges, spotting any caves and/or rock shelters and plotting them on the maps. One cave near the spring in Rough Spring Canyon looked promising. It was a narrow crawlway, about 2 feet wide and 12-18 inches high. I entered and made it back about 15 feet before the ceiling lowered too much. But the floor was a soft dirt, and I tried a little digging. I made quick progress in the loose dirt, and it was obvious the cave kept going, but it was difficult because there was nowhere to put the dirt. I had to pull it all the way back to the entrance to dispose of it. There just wasn't room for me and all that dirt in that little crawlway. And all the digging raised a choking dust, that clogged nostrils and got in your eyes. Still it looked promising, so I took turns with Keith Heuse, Danny Sherrod and Harry (from San Antonio), and we dug out another 15 feet of passage in the next 3 hours. Eventually, a thunderstorm blew up and chased us out of the flood-prone canyon, and it will take another trip to see how much further it goes.

On Monday we went to the already known Fawcett's Cave. A 20-foot rappel gave us access to the entrance pit, and inside it proved to be a spectacular cave, some 1000 feet long, and most of that length is extensively decorated with stalactites, stalagmites, bacon, soda straws, and floor-to-ceiling columns, some of which were 25 feet tall and 4 feet across. It was a truly beautiful cave, though we did find some graffiti at the back, dating back to the 1930's. We conducted some surveying for the cameras (for the "Made in Texas" program on caving due to be seen on PBS later this year). And we even did a few underground interviews. It will be interesting to see how much makes it into the final edited version.

After caving for 4 or 5 hours, we drove back across the park and headed for the Devil's River and a welcome soak in the springs. But about the time we got into the water, a norther blew through, and north winds of 30-40 mph funneled down the canyon, cutting our swimming short. We found out later that we were lucky; that same front had produced sleet and snow from the panhandle to the Dallas-Fort Worth area, and as far south as Sonora, just 50 miles to our north.

Tuesday morning, Shari and I left camp after breakfast and headed south to Seminole Canyon State Park to view Indian pictographs before heading home. But other members of the group remained till the next weekend, covering even more of the park. There were not any major new caves found, but there are a lot of leads to be checked out, and a lot more ridge-walking to do. If you're interested, Keith Heuse is in charge of the Devil's River Project.

CAVING CUISINE
From the Kitchen of Dale Ellison

Campfire Twist Bread

Use biscuit or pancake ready-mix flour, allowing one cup per camper. Mix into stiff dough, using less liquid (either milk or water) than usual. Press dough flat, cut in 1-inch strips, wind these spirally around clubs of green wood. Clubs should be about 2 inches in diameter and 3 1/2 feet long. Hold over a bed of coals, turning stick constantly so bread browns evenly on all sides without burning. Eat with jam, jelly or syrup.

City Forms Lechuguilla Cave Task

A Lechuguilla Cave task force has been formed for the city of Carlsbad to make recommendations on how the cave might be approached from a community level in order to find its possible impact on Carlsbad tourism.

The committee was formed by Mayor Eob Forrest to "bring together key community representatives with officials of the National Park Service in order to share information about the survey work currently under way at

Lechuguilla, and to make recommendations regarding how this important discovery should be approached from a community level."

There has been talk of designating the cave a wilderness area, which would prohibit the building of roads, buildings and other development of facilities for those visiting the cave. Last year, when two *Carlsbad Current-Argus* staff members visited the cave, they had to drive about 10 miles on a gravelled road and then walk about one mile to get to the entrance.

The cave features crystal formations growing under water, plus other wonders to the eye. It is reportedly bigger than the Carlsbad Caverns.

In November 1983, Ron Kerbo, Carlsbad Caverns National Park cave specialist, reportedly said that if the cave is ever opened to the public, that time would be a long way off, since exploration is still continuing. He also was quoted in a C-A news release as saying that, because of the rugged terrain, it would cost millions of dollars to develop the cave for public use.

It was reported that there have been moves by the National Park Service to have Lechuguilla Cave declared a wilderness.

In appointing the committee,

which is charged with reporting back to Forrest in 120 days on the future of Lechuguilla, Forrest said, "I believe one of the most important decisions in the future of our city is in what direction we, as citizens, want to see the Lechuguilla Cave developed.

"As you may realize, this will be quite a difficult task, but I feel like with the wide representation of the committee that you will be able to collectively come up with a solution."

Appointed to the committee are Kerbo; Mayor Pro Tem Gary Perkowski; city councilman A.E. Jackson; Mike Currier of Guaranty Title; Mike Hood, operations manager for General Telephone; Nancy Brantley, Eddy County commissioner; Joe Florez; Dodie Oden of Western Commerce Bank; Stasia Spurrier; Perry Denton of Denton Funeral Home; and educator Jed Howard.

Force

The above article appeared in the "Carlsbad Current - Argus" on 7 March 1989, and was reprinted in the March - April issue of "Southwestern Cavers". Many cavers in the Carlsbad area are incensed that cavers are not better represented on the Mayor's committee. Ron Kerbo is the only active caver included, and of course his first duty is to represent the National Park Service, not the caving community.

Cavers who want to see Lechugilla remain a wilderness and not be developed as a commercial cave, NEED TO WRITE letters to Sen. Pete Dominici, 434 Dirksen Senate Office Building, Washington, D.C. 20510. It would also be good to write to U.S. Secretary of the Interior, Manuel Lujan, as well as your own representative and senators to let them know how you feel.

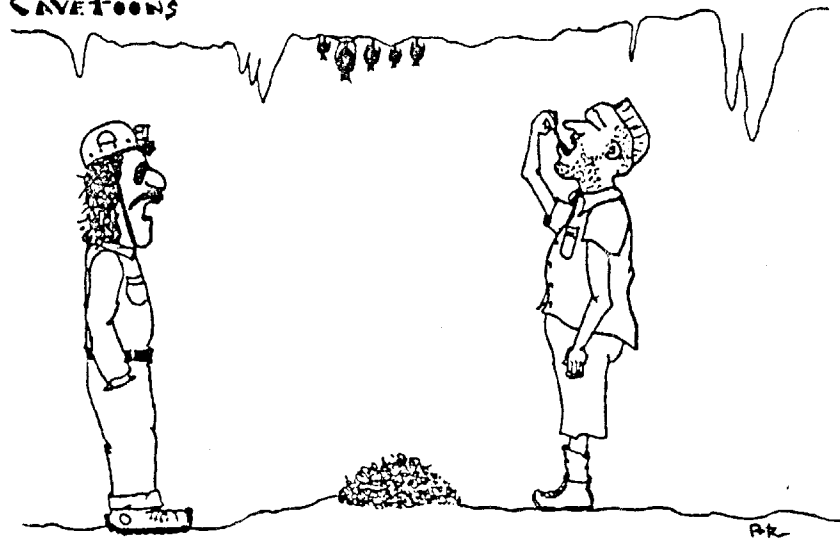
